壹、主席致詞暨院務報告

- 一、本校於《遠見》雜誌 2025 年「大學五長互評」調查中，榮獲農林漁牧領域全國第一；依據大學問網站 2025 年「高中生最愛熱門百大科系調查」，本院獸醫學系榮列全國第 3 名。
- 二、恭喜獸醫系鄧紫云助理教授榮獲 114 年度國科會「吳大猷先生紀念獎」。
- 三、獸醫系林荀龍副教授主持之「浪愛無國界：流浪動物減量與福祉實踐」計畫，於 5 月底派遣 4 人團隊前往帛琉，進行犬貓義診與絕育手術，並協助當地建立標準化流程，以改善遊蕩犬貓問題。
- 四、本院於 5 月 17 日與中華民國獸醫學會共同舉辦「動物健康一體暨動物實驗替代科技國際研討會」，邀請日本、馬來西亞及國內學者專家，聚焦 One Health 與 3Rs 替代科技議題進行深度交流。
- 五、為呼應國際趨勢並強化跨領域合作，院長安排於9月24日至9月27日帶領微衛所徐所長、趙教授、診中歐主任、2位博士班學生及獸醫系以盈老師，拜訪北海道大學One Health研究中心主任（Prof. Motohiro Horiuchi），深入了解其單位運作模式、研究方向、跨域整合策略，作為本院附屬單位「One Health」中心規劃與定位之重要參考依據。
- 六、本院積極推動動物實驗替代科技（3Rs）融入教學。獸醫學系除已添購乳牛產科仿生教具、犬隻仿生教具及魚類抽血模型外，並規劃再購置數位解剖操作臺，透過 3D 虛擬解剖圖像，協助學生反覆操作學習，提升對動物器官相對位置之認知，加深學習成效。
- 七、本院與美國愛荷華州立大學（Iowa State University, ISU）合作辦理之獸醫學士雙聯學位（DVM）計畫，113 學年度已有 2 位首屆畢業生，展現優異成果，充分肯定本院推動國際合作之成效。
- 八、與泰國清邁大學（Chiang Mai University, CMU）獸醫學院簽訂博士雙聯學

位協議書草案，經多次溝通修正，將提請本次會議審議。另獸醫系已作業邀請該院院長 Nganvongpanit 博士擔任本學期客座教授，預計於 12 月來校授課，除深化雙邊學術交流外，亦展現本院持續推動跨國高等教育合作之決心，進一步提升研究與教學能量。

- 九、馬來西亞獸醫局於 7 月來函通知，需重新辦理獸醫教育機構審查作業。感謝各單位協助獸醫系完成第一階段書面審查文件，並已於 8 月 20 日順利寄出。另為推動獸醫系學歷之歐盟認證，學院預計於明（115）年 1 月成立「國際認證辦公室」，不僅有助於提升本院獸醫教育體系之國際認可度，並可使畢業生學歷獲得海外專業機構承認，拓展國際發展與執業機會。
- 十、「國際獸醫防疫人才培訓中心暨獸醫教學醫院大樓」工程於 8 月 27 日舉行上樑祈福典禮，預計 116 年 2 月 18 日完工。為取得使用執照並維持獸醫教學醫院營運所需，扣除工程標餘款後，獸醫教學醫院已向校務基金借支 9,200 萬元，業經 7 月 9 日 113 學年度第 5 次校務基金管理委員會決議通過，並由營繕組辦理後續擴充招標事宜。
- 十一、本院各系所已完成第四週期教學單位自我評鑑作業，並依院評教師意見修正報告書；實地訪評日期預定於明（115）年 3 月 3 日至 3 月 5 日辦理。
- 十二、依據人事室 114 年 9 月 16 日來函，法務部廉政署已設置「揭弊者保護專區」，提供各類宣傳海報、網頁及常見問答等資料下載，請各單位加強宣導與運用。
- 十三、依人事室統計，截至 9 月 1 日，本院依勞保、公保人數 3% 計算，進用身心障礙人數不足 1.5 人。未達標準者，須依差額人數乘以每月基本工資繳納補償費，請各單位於聘僱時優先考慮進用身心障礙者。
- 十四、依「資通安全責任等級分級辦法」，一般使用者及主管每年須接受 3 小時以上資安通識教育訓練。截至 9 月 18 日止，計資中心統計本院資安時數達成率為 68%，請各單位轉知所屬務必儘快完成教育部資安時數之要求。

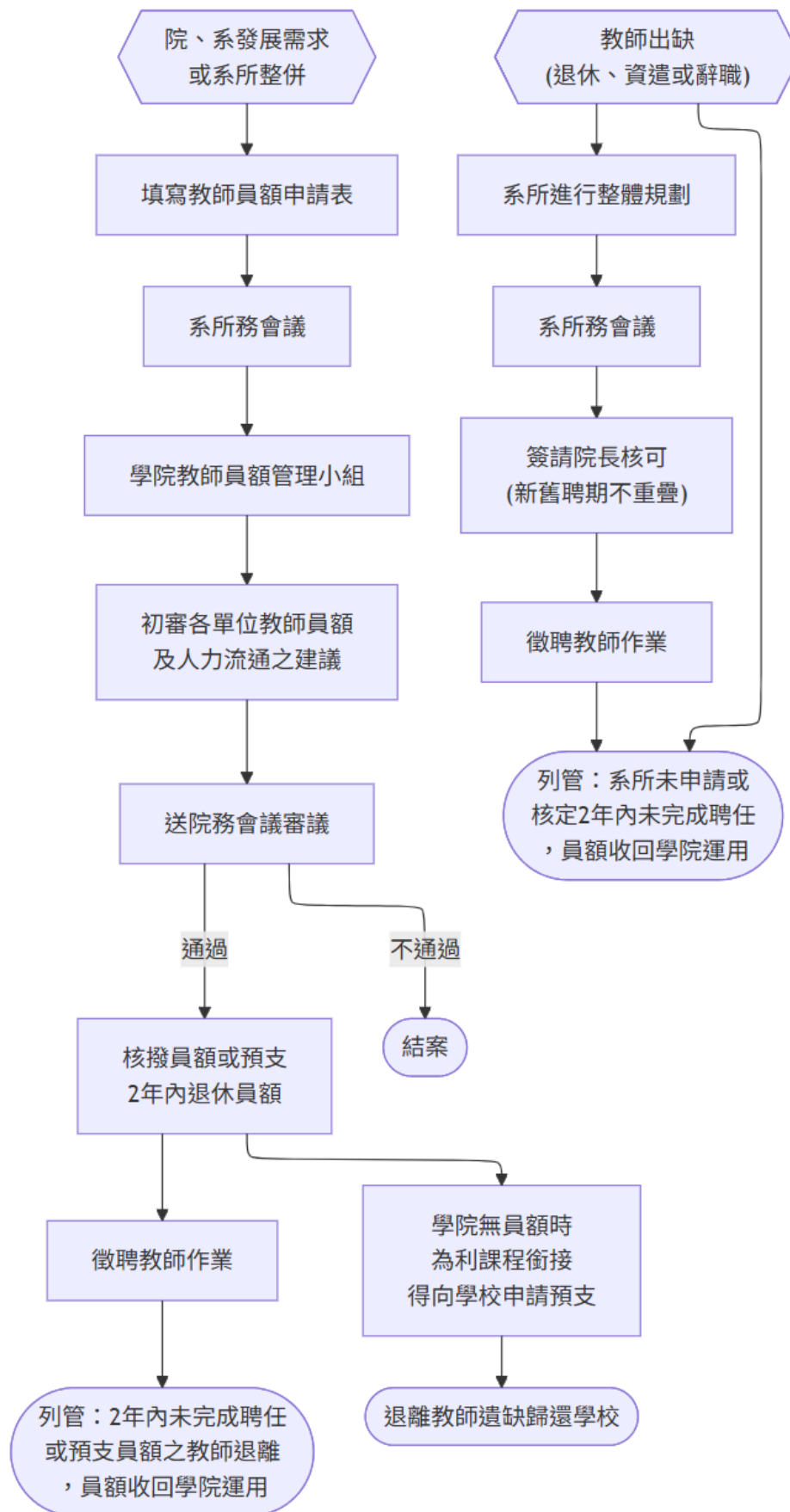
- 第一條 國立中興大學獸醫學院（以下簡稱本院）為適當調配教師員額，充分運用教學資源，以利全院卓越之發展，特依據本校教師員額管理辦法第六條訂定本院教師員額流通辦法（以下簡稱本辦法）。
- 第二條 本院設置「教師員額管理小組」（以下簡稱本小組），本院各教學單位，如有下列情事之一者，向本小組提出員額調配申請，申請表如附表。
- 一、院、系所發展所需。
- 二、系所整併。
- 系所如有學院員額聘任之教師出缺（如退休、資遣或辭職等），得通盤考量課程銜接、擬聘人選之學術專長、教學計劃（含大學部）、空間及經費資源等配套措施，經系所務會議審議通過後，依行政程序報請院長核准使用該員額。
- 前項員額如系所未提出申請或經核准二年內未完成聘任程序，則由學院收回統籌運用。
- 第三條 本院為調配院聘、各系所教師員額，應參酌各系所教師員額狀況及發展需求（各系所應訂定中期發展計畫）、學院整體發展規劃及學術發展趨勢辦理之。本小組負責初審各教學（研究）單位教師員額及人力流通之建議事宜，經院務會議通過後實施。
- 第四條 本小組置委員五人，院長為當然委員兼召集人；並由院長邀請學者專家一名，與本院各教學單位分別推薦一名教師代表組成之。
- 第五條 小組開會時，各委員均應親自出席，應有委員三分之二以上出席始得開議，議案之通過應獲出席委員三分之二以上之同意。
- 第六條 本小組應邀請教師員額申請單位之主管列席說明。
- 第七條 本辦法經院務會議通過並報校長核定後施行，修正時亦同。

**NATIONAL CHUNG HSING UNIVERSITY
COLLEGE OF VETERINARY MEDICINE
Regulations for the Circulation of Faculty Quotas**

- Article 1 The National Chung Hsing University College of Veterinary Medicine (“the College”) formulates the *Regulations for the Circulation of Faculty Quotas* (“the Regulations”) based on Article 6 of the NCHU *Regulations for the Management of Faculty Quotas*, with the goal of effectively utilizing the College’s faculty quotas, optimizing teaching resources, attracting outstanding talent, and enhancing the College’s competitiveness.
- Article 2 The College shall establish a “Faculty Quota Management Group” (“the Group”). Academic units within the College may submit applications for the allocation of faculty quotas to the Group under the following circumstances:
1. Development needs of the College or departments;
 2. Consolidation of departments.
- In the event that a faculty position originally allocated as part of the College’s quota becomes vacant (e.g., due to retirement, dismissal, or resignation), the use of such quota shall require comprehensive consideration of the following factors: curriculum continuity; the academic expertise and teaching plans (including undergraduate teaching) of the proposed candidate; and supporting conditions such as space and budgetary resources. The proposed use must be reviewed and approved by the Department or Institute Affairs Meeting and submitted to the Dean for final approval through the appropriate administrative procedures.
- If the department or institute does not plan to use the aforementioned faculty quota, or fails to complete the recruitment process within two years after approval, the quota shall be reclaimed by the College for centralized allocation.
- Article 3 In the allocation of faculty quotas for academic units, the Group shall consider the status and development needs of each unit's faculty quotas (with each unit required to formulate a medium-term development plan), the overall development plan of the College, emerging academic trends, and the optimal utilization of teaching resources. The Group is responsible for the preliminary review of recommendations related to the allocation and circulation of faculty quotas and personnel. These recommendations shall be implemented upon approval by the College Affairs Meeting.
- Article 4 The Group shall consist of five members: the Dean, who serves as an ex-officio member and convener; one scholar or expert invited by the Dean; and one faculty representative nominated by each academic unit of the College.
- Article 5 All members must attend the Group’s meetings in person. A quorum shall require the presence of at least two-thirds of the members. Resolutions shall be approved by at least two-thirds of the members present.
- Article 6 The Group shall invite the heads of academic units requesting faculty quota to attend the meetings and provide explanations as needed.
- Article 7 The Regulations shall be implemented upon approval by the College Affairs Meeting and the President. Any amendments shall follow the same procedure.

第一條 國立中興大學獸醫病理生物學研究所（下稱本所）為維護研究生之學位

論文品質，依國立中興大學博士班學位考試細則及國立中興大學碩士班學位考試細則訂定國立中興大學獸醫學院獸醫病理生物學研究所學位論文品質與管考準則（下稱本準則）。

第二條 本所研究生之論文指導教授資格依國立中興大學博士班章程第六條及國立中興大學碩士班章程第三條規定辦理。

本所每位專任教師每學年新收指導博士生人數二名，碩士生人數二名為限(陸生、僑生、港澳生及外籍生等外加員額不在此限)。

第三條 研究生之學位論文須符合本所專業領域，如有爭議，依國立中興大學博士班學位考試細則及國立中興大學碩士班學位考試細則辦理。

- Article 1 : The Institute of Veterinary Pathobiology (hereinafter referred to as "the Institute") establishes these Guidelines for Thesis Quality control (hereinafter referred to as "the Guidelines") to ensure the quality of graduate theses. These Guidelines are formulated in accordance with the NCHU Implementation Guidelines for Doctoral Degree Examination and the NCHU Implementation Guidelines for Master's Degree Examination.
- Article 2 : The qualifications for thesis advisors of graduate students in the Department shall comply with Article 6 of the NCHU Doctoral Program Regulations and Article 3 of the NCHU Master's Program Regulations of National Chung Hsing University.
Each full-time faculty member in the Department may supervise up to two new doctoral students and two new master's students per academic year. This limit does (not include additional quotas for students from Mainland China, overseas Chinese students, students from Hong Kong and Macau, and international students.)
- Article 3 : The thesis of a graduate student must align with the professional fields of the Institute. If any disputes arise regarding, the matter shall be handled in accordance with the NCHU Implementation Guidelines for Doctoral Degree Examination and the NCHU Implementation Guidelines for Master's Degree Examination.
- Article 4 : The first draft of the oral thesis for the graduate thesis must undergo an originality check. The results are reviewed by the oral examination committee. After revisions are completed, the thesis must undergo another originality check. The similarity score, excluding the table of contents, materials and methods, references, and appendices, must be less than 25%. Journal articles published during the graduate student's studies may be excluded from the comparison.
- Article 5 : These guidelines shall take effect upon approval by the Institute Affairs Meeting and the College Affairs Meeting, and shall be submitted to the Office of Academic Affairs for record- keeping. The same procedure applies to any future amendments, and the guidelines shall be enforced from the date of announcement.

This Agreement on dual doctoral degree program is a supplement to the Memorandum of Understanding entered into as of MOU on ... [Date] between the College of Veterinary Medicine, Department of Veterinary Medicine, the Graduate Institute of Microbiology and Public Health and the Graduate Institute of Veterinary Pathobiology, National Chung Hsing University, Taiwan, and the Faculty of Veterinary Medicine, Chiang Mai University, Thailand.

This Agreement on dual doctoral degree program is entered into on [Date] by and between the College of Veterinary Medicine, Department of Veterinary Medicine, The Graduate Institute of Microbiology and Public Health and The Graduate Institute of Veterinary Pathobiology, National Chung Hsing University, hereinafter referred to as “NCHU” and the Faculty of Veterinary Medicine, Chiang Mai University hereinafter referred to as “CMU” with aim to establish a double degree program for a Doctor of Philosophy program in Veterinary Science.

Whereas;

- The Doctoral Degree Program of CMU is referred to as the “Doctor of Philosophy program in Veterinary Science (International Program) Type 1.1 (Master’s degree based)”.
Degree Abbreviation: **Ph.D.**
- The Doctoral Degree Program of NCHU is referred to as the “Doctor of Philosophy Program in Veterinary Science”, offered through the following academic units under the College of Veterinary Medicine:
 - Department of Veterinary Medicine
 - the Graduate Institute of Microbiology and Public Health
 - the Graduate Institute of Veterinary PathobiologyDegree Abbreviation: **Ph.D.**

HEREBY WE AGREE:

1. Admission/Entrance Process

- 1.1. Both institutions shall independently arrange the entrance examination and make the decision to accept their own students.
- 1.2. The program shall provide students with joint supervision on study and research.
- 1.3. Students must fulfill the foreign language requirement prior to admission to the Graduate School.
- 1.4. Students applying for the dual PhD degree program must complete the Co-Supervision Agreement (Appendix 1).

1.5. The application and graduation requirements are listed in Appendix 2.

2. Number of Students

Each university will accept up to two (2) students yearly under this agreement. However, if necessary, more than two students may be accepted based on the discussion between both universities.

3. Tuition Fee and Scholarship

3.1. Tuition Fee

The tuition fee shall be paid to the home university separately.

3.1.1. For the Doctor of Philosophy Program in Veterinary Science (International Program) at CMU, the tuition fee/semester will be 45,000 THB for international students (270,000 THB per program) and 25,000 THB for Thai students (150,000 THB per program).

- *A maximum of 2 potential NCHU students admitted to the CMU dual degree program will be waived for CMU's tuition and fees.*

3.1.2. For the Doctor of Philosophy Program in Veterinary Science at NCHU, according to the full tuition fee of the Colleges of Veterinary Medicine, the tuition fee/semester will be approximately 54,000 TWD. for international students.

- *A maximum of 2 potential CMU students admitted to the NCHU dual degree program will be waived for NCHU's tuition fee.*

3.2. Scholarship

Both institutes will provide the scholarship.

3.2.1. For NCHU students admitted to the dual degree program at CMU, the students are encouraged to apply for scholarships for international students; the scholarship opportunities are as follows:

3.2.2. For CMU students admitted to the dual degree program at NCHU, the students are encouraged to apply for scholarships for international students; the scholarship opportunities are as follows:

A. Students may apply for NCHU Scholarship, which provides monthly stipend of 8,000 TWD, depending on the scholarship type and availability of funding.

B. Students can also apply to the Ministry of Education

(<https://english.moe.gov.tw/cp-24-16833-23C09-1.html>) and the Ministry of Foreign Affairs Taiwan scholarship (<https://en.mofa.gov.tw/cp.aspx?n=1325>).

C. Students may apply for an NCHU scholarship and other scholarships i. e., Ministry of Education and the Ministry of Foreign Affairs Taiwan scholarship at the same time. If a student awarded both the Taiwan Government Scholarship and NCHU scholarship, their NCHU scholarship shall be canceled in accordance with NCHU regulations, which stipulate that recipients may not receive additional scholarships exceeding a combined total of 15,000 TWD per month. D. Scholarship application periods: To apply for the NCHU Scholarship, applicants shall indicate their intent by selecting “Yes” in response to the question regarding scholarship application on the application form.

4. Doctoral Thesis and Degree Awarded

4.1. Both institutions shall jointly hold the doctoral thesis examination.

4.2. Each institution shall award the certificate for the double degree program.

5. Other Terms

5.1. This Agreement shall be in effect for five (5) years from the date of signing and may be revised or renewed by the agreement of the two institutions.

5.2. Revisions or modifications may be proposed at any time, effective from the date of the written agreement signed by both institutions.

5.3. This Agreement may be terminated through written notification by either institution six (6) months prior to the desired termination date without penalties or liabilities.

5.4. In case of termination, the programs or activities that have already been approved by both institutions by the date of the written notice shall be allowed to be completed under the conditions of the Agreement.

5.5. This Agreement will be written in English and made in two copies, and each institute will keep one copy.

1. Application periods for program admission

2. The Requirements of Applicant

2.1. The applicant must have a Master of Veterinary Medicine or other Master's degree related to veterinary sciences, biology, or life sciences.

2.2. The applicant has gained an English Proficiency Test score;

- TOEFL score of 213 (CBT) or 79 (IBT)

- IELTS or IELTS Indicator score of 6.0

The English Proficiency Test results should not exceed 2 years from the exam date.

2.3. A research proposal of about 2-5 pages explaining the research plan at CMU and/or NCHU.

2.4. An international student shall assume responsibility for expenses related to private health insurance. However, the value of insurance coverage is voluntary, and private health insurance shall bear the coverage period or extension to cover an international student throughout the time of the student's status.

3. Period of Study

3.1. The period of study;

CMU/NCHU dual PhD: Three (3) to six (6) years

Students may spend 12 to 24 months at the host university, with the exact duration to be determined by the supervising professors at both institutions. According to current NCHU regulations, students are required to complete four semesters of study at NCHU. Should this requirement be revised in the future, the updated regulation shall apply.

3.2. The periods of the CMU semester are as follows;

The 1st semester starts from June to October.

The 2nd semester starts from November to March.

3.3. The periods of the NCHU semester are as follows;

The 1st semester starts from September to January.

The 2nd semester starts from February to June.

3.4. Each institution shall approve the extension of study/enrollment if necessary.

4. Program Structure

4.1. The CMU Program requires 48 credits or enrollment, including

4.1.1. VSC898 (653898) Doctoral Thesis 48 credits (for GPAX calculation only)

4.1.2. Four additional requirement courses, in which the grade will not be included in GPAX calculation, are as follows;

VSC791 (653791) Seminar in Veterinary Science 1 - 1 credit

VSC792 (653792) Seminar in Veterinary Science 2 - 1 credit

VSC891 (653891) Seminar in Veterinary Science 3 - 1 credit

VSC892 (653892) Seminar in Veterinary Science 4 - 1 credit

4.1.3. A student must complete a qualifying examination to evaluate his/her ability before presenting a proposal.

4.2. The NCHU Program requires 30 credits

Students require 30 credits for graduation, 4 credits for core courses, 14 credits for elective courses, and 12 credits for a dissertation.

The core and elective courses are listed in Table 1.

4.3. Research requirements and thesis evaluation process

Ph.D. Students must get the “Education on Academic and Research Ethics” course certification before applying for the oral defense. The passing grade for oral defense is 70.

5. Regulations for Graduation

CMU/ NCHU

5.1. A student must complete the curriculum and meet all study program requirements.

5.2. A student must have successfully defended a thesis.

5.3. Publications

CMU: The whole or part of the thesis must be published or accepted with the student being the 1st author of 2 articles **and** published in a journal listed in Scopus, IEEE, PubMed or Web of Science as an original article or a research article or Systematic Review and Meta-analysis **and** the affiliation of the student in publication must be as follows: “Faculty of veterinary Medicine, Chiang Mai University”. If any journal does not clearly specify “Original article”, “Research article”, or “Systematic Review and Meta-analysis”, the student must submit additional evidence/document/letter from the editor to declare the type of the paper.

NCHU: The articles have to be “Original article”, “Research article” or “Meta-analysis. There are two options for publication requirements.

- The whole or part of the thesis must be published or accepted with the student being the sole **primary author** of **one** research paper listed in an **SCI Q1 journal** or in a SCI journal with an **impact factor of 3.5 or higher**,

OR

- The student must be the sole **primary author** of **two** research papers: one published in a **journal listed in SCI**, and the other in an English **peer-reviewed research journal**.

5.4. Poster or oral presentation

CMU: Students must present part of the thesis as a poster or an oral presentation at an international conference, at least 1 presentation. Proof of participation, indicating that the student was the presenter, must be submitted.

NCHU: Students must present part of the thesis as a poster or an oral presentation at an international conference, at least 1 presentation. Proof of participation, indicating that the student was the presenter, must be submitted.

5.5. Exception:

The graduation requirements stipulated in Clauses 5.3 and 5.4 are specifically designed for CMU students enrolled in the dual Ph. D. degree program between CMU and NCHU. These requirements shall not apply to NCHU students enrolled in the same dual Ph.D. program NCHU students shall be subject to the graduation requirements of their original department and institutional regulations.

案由：擬修正「國立中興大學獸醫學院獸醫教學醫院契約進用獸醫師待遇支給表」，提請院務會議審查。

說明：

- 一、本醫院為延攬優秀獸醫師人才留任及培育訓練，提升獸醫師工作士氣及效能，並達到激勵作用擬修正「國立中興大學獸醫教學醫院契約進用獸醫師待遇支給表」之實習醫師與住院醫師薪資。
- 二、目前實習醫師薪資係依基本工資標準支給，惟因工作性質須配合排班、值夜、處理臨床突發狀況，工作負荷與責任較高。為鼓勵實習醫師安心投入臨床醫療工作，提升其留任意願，強化醫院穩定運作，擬將薪資自現行基本工資提高至符合實際工作內容與市場行情之水準，爰參考 114 年 5 月 7 日第 471 次行政會議決議通過之「國立中興大學契約進用職員待遇支給表」D 級別第一級支給，調整後薪資為 36,190 元。
- 三、現行住院醫師待遇自 106 年訂定至今未曾調整，參考 114 年 5 月 7 日第 471 次行政會議決議通過之「國立中興大學契約進用職員待遇支給表」D 級別，並依據 106 年訂定標準，第一年住院醫師以第六級支給、第二年住院醫師以第八級支給、第三年住院醫師以第十級支給。調整後住院醫師第一年支給 40,560 元、第二年支給 42,450 元、第三年支給 44,580 元。
- 四、依據 114 年 9 月 1 日在職住院醫師 16 名、實習醫師 6 名估算，本案通過後，實習醫師部分每月將增加 54,720 元，住院醫師增加 104,845 元，合計 159,565 元(含勞健保)。本院本年 1 月至 7 月餘絀共計 1,538,868 元，調整薪資部分，仍屬可控範圍，不致對財務運作造成重大衝擊。本待遇支給表擬訂於 114 年 10 月 1 日起實施適用。
- 五、檢附待遇支給表修正草案對照表、原支給表、本校「契約進用職員待遇支給表」、調薪評估表、獸醫教學醫院院務會議紀錄各 1 份。
